- d) This MOU may be voidable, ceased or terminated as per mutual understandings.

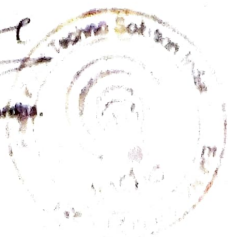
